I. <u>Call to Order:</u> The meeting was called to order at 9:05 AM 9.05 by a motion made by Liz Legault and seconded by Mark Bodwell. The motion carried unanimously by roll call vote: Jeff Szymaniak, Mark Bodwell, Peter Schafer, Matt Ferron, Chris Godino, Liz Legault, and Julie Hamilton.

A. FY22-May Financials

B. **FY22 Budget Update-** Clarice reviewed the budget and called attention to the North River School budget and advised that 45-day placements have made up a lot of the population at the school and Clarice thinks this trend will continue. The last five years has shown an average of 33 to 35 students but this year with the addition of the new principal it has increased the budget. In addition, Clarice reviewed the request for the Board to vote on Option 1: up to \$300,000 to the Capital Reserve, an NRS loan payment of \$160,000 and a pre-pay of van loans in the amount of \$100,000. After the completion of the option 1 payments there will be a projected surplus of \$15,607.

Motion: Liz Legault made a motion to approve Option I: up to \$300,000 to the Capital Reserve, an NRS loan payment of \$160,000 and a pre-pay of van loans in the amount of \$100,000. C. Independence Academy Financial Summary for FY22: Clarice reviewed the FY22 financial summary of Independence Academy. The projected loss is \$20,000 which is all from the cost of transportation.

Independence Academy and Harvard Medical School Research Study: Clarice informed the Board that IA students participated in a study with Dr. Emily Hennessey from Harvard's Recovery Research Institute. For participation, IA received a \$1000 honorarium. The study involved a Social Identity Mapping task where students were asked questions about their social groups to create a visual map of their social network and an interview about their experience doing the social identity mapping. The purpose of this study is to help improve the social identity mapping process for other adolescents so that we can better understand what and how social aspects influence their recovery process.
